EXECUTIVE SUMMARY

This report provides a comprehensive analysis of the Council on American-Islamic Relations (CAIR) based on IRS Form 990 filings and open-source intelligence. The investigation mapped 16 CAIR entities with combined annual revenues exceeding \$37 million and identified significant board member cross-pollination across chapters and related organizations.

KEY FINDINGS

- 1. Financial Scale: CAIR California alone reports \$18.9M in annual revenue (2024), with CAIR National at \$9.4M
- 2. Board Cross-Pollination: Multiple individuals serve on boards of both state chapters and national CAIR
- 3. Executive Compensation: Top executives earn \$200K-\$275K annually
- 4. Government Funding Controversy: CAIR California received \$26M+ in government grants (2022-2023) with reporting irregularities
- 5. Historical Terror Financing Connections: FBI severed relations in 2008; named unindicted co-conspirator in Holy Land Foundation case
- 6. Foreign Funding: Documented receipt of funds from Qatar (\$405K), Saudi Arabia, and UAE (total ~\$1.2M)

4. Foreign Funding Disclosure: Full disclosure of foreign government contributions

For State Attorneys General

1. Charitable Registration Review: Verify compliance with state charity registration requirements
2. Grant Spending Audit: Trace federal funds through sub-granting arrangements
3. Board Independence Review: Evaluate conflicts of interest from cross-board service

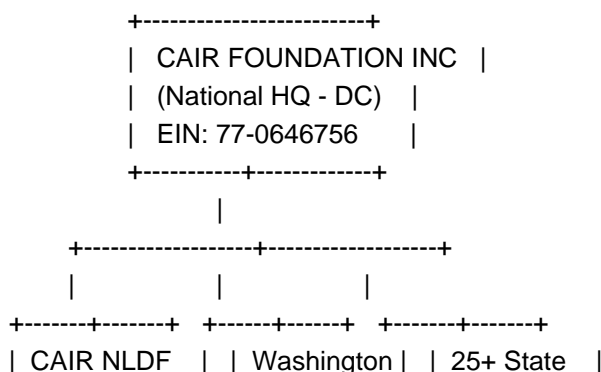
